

As per the provisions of Rule 12, under Batteries (Management and Handling) Rules, 2001 annual compliance status report for the year 2017-18 is enclosed (**Annexure : I**) herewith for your perusal please.

Under Batteries (Management and Handling) Rules, 2001 M.P. Pollution Control Board has requested to CPCB vide letter No 1824 dated 22/06/2017 for issue of notices to lead acid batteries importers which are not complying the conditions of the import certificate issued by CPCB (**Annexure : II**). In response of the same CPCB has issued notices to 19 Nos. lead acid batteries importers. Out of 19 No. only two [M/s Blow Hot Kitchen Appliances Pvt. Ltd., Indore and M/s Universal Cables Ltd., Satna] have responded rest are still not complying the conditions of certificate (**Annexure : III**).

For effective implementation of Batteries (Management and Handling) Rules, 2001, Board has also requested to Central Pollution Control Board to direct the manufacturer exist in the country at the level of Central Pollution Control Board for providing the list of dealers to their respective SPCBs (**Annexure : IV**). As per available information of the manufacturers, MPPCB issued notices to 10 LAB manufacturers out of which only M/s Luminus Power Technologies Pvt. Ltd., (**Annexure : V**) have responded.

With reference to the above subject, as you are aware of Batteries (Management and Handling) Rules, 2001 are applicable from 16th May 2001 by notification of the Government of India, Ministry of Environment and Forest and Amended by notification S.O. 1002 (E) dated 4th May 2010. Therefore you are instructed to ensure the following compliance of responsibility by your dealer as per sub rule 7(i) to 7[(vii) (a)] of Batteries (Management and Handling) Rules, 2001 Amended as Rule, 2010 :-

1. ensure that the used batteries are collected back as per the Schedule against new batteries sold.
2. give appropriate discount for every used battery returned by the consumer.
3. ensure that used batteries collected back are of similar type and specifications as that of the new batteries sold
4. File half-yearly returns of the sale of new batteries and buy-back of old batteries to the manufacturer in Form V by 31st May and 30th November of every year.
5. ensure safe transportation of collected batteries to the designated collection centres or to the registered recyclers.
6. ensure that no damage is caused to the environment during storage and transportation of used batteries.
