GRANTING AUTHORISATION FOR GENERATION OR STORAGE OR TREATMENT OR REFURBISHING OR DISPOSAL OF E-WASTE OR REFURBISHER

1. The Occupier of **M/s. Star Mobile Service Center (Samsung Authorized service Centre)**, is hereby granted an authorisation for generation, storage, treatment, disposal of e-waste on the premises situated at **Plot No. G1, Ground Floor, Yashwant Plaza, Opposite railway station, Indore** for the following:
 - a. Quantity of e-waste- **0.31 M.T**
 - b. Nature of e-waste- Cellular telephones ITEW15, whole or in part discarded as waste by the consumer or bulk consumer as well as rejects from refurbishment and repair processes.
2. The authorisation shall be valid for **Life Time**
3. The e-waste mentioned above shall be treated/ disposed off in a manner Environmentally Safe at **Samsung India Electronics Pvt. Ltd. C/o Ingram Micro India Pvt. Ltd. 20 Udyog Vihar Ecotech – II, Greater NOIDA – 201306** premises.
4. The authorisation is subject to the conditions stated below and such conditions as may be specified in the rules for the time being in force under the Environment (Protection) Act, 1986.

Terms and conditions of authorization

1. The authorisation shall comply with the provisions of the Environment (Protection) Act, 1986, and the rules made there under.
2. The authorisation or its renewal shall be produced for inspection at the request of an officer authorized by the concerned State Pollution Control Board.
3. Any unauthorised change in personnel, equipment as working conditions as mentioned in the application by the person authorized shall constitute a breach of his authorisation.
4. It is the duty of the authorised person to take prior permission of the concerned State Pollution Control Board to close down the operations.
5. Refurbisher shall have system to manage leakage of coolant/refrigerant gases and compressor oils from used electrical and electronic equipment during refurbishing operations.
6. The refurbisher shall have refurbishing area ventilated and proper dust control equipment.
7. Any E-waste generated during refurbishment should be collected separately and send to authorized recyclers.
8. Refurbisher shall have Water proof working area.

9. The Refurbisher shall maintain records of the e-waste purchased and refurbished in Form-2 and shall file annual returns of its activities of previous year in Form-3 to the concerned State Pollution Control Board on or before 30th day of June of every year.

10. The State Pollution Control Board may, if in its opinion, the holder of refurbisher authorization has failed to comply with any of the condition of the authorization or with any provisions of the act or these rules and after giving a reasonable opportunity of being heard and after recording reasons thereof in writing cancel or suspend the authorization issued under these rules for such period as it considers necessary in the public interest and inform Central Pollution Control Board within 10 days of cancellation.
