
Annual Report for 2016-17 as per the provisions of the Plastic Waste Management, Rules, 2016

1. Introduction:

The Government of India, Ministry of Environment and Forests published the Plastic Waste (Management and Handling) Rules, 2011 vide notification number S.O 249 (E), dated 4th February, 2011 by, as amended from time to time, provided a regulatory frame work for management of plastic waste generated in the country. The Central Government reviewed the existing rules to implement these rules more effectively and to give thrust on plastic waste minimization, source segregation, recycling, involving waste pickers, recyclers and waste processors in collection of plastic waste fraction either from households or any other source of its generation or intermediate material recovery facility and adopt polluter's pay principle for the sustainability of the waste management system. In exercise of the powers conferred by sections 3, 6 and 25 of the Environment (Protection) Act, 1986 (29 of 1986), and in supersession of the Plastic Waste (Management and Handling) Rules, 2011, the Central Government published the **Plastic Waste Management Rules, 2016** vide notification no G.S.R 320(E), New Delhi, the 18th March, 2016.

These rules are applicable to every waste generator, local body, Gram Panchayat, manufacturer, Importers and producer but the rule 4 is not applicable to the export oriented units or units in special economic zones, notified by the Central Government, manufacturing their products against an order for export, Provide this exemption shall not apply to units engaged in packaging of gutkha, tobacco and pan masala and also to any surplus or rejects, left over products and the like.

As per the provision of the Rule, 17 Every person engaged in recycling or processing of plastic waste shall prepare and submit an annual report in Form-IV to the local body concerned under intimation to the concerned State Pollution Control Board or Pollution Control Committee by the 30th April, of every year. Every local body required to prepare and submit an annual report in Form -V to the concerned Secretary of the Urban Development Department under intimation to the concerned State Pollution Control Board or Pollution Control Committee by the 30th June, every year. The State Pollution Control Board has to prepare and submit an annual report in Form VI to the CPCB on the implementation of these rules by the 31st July, of every year.

It is to be made clear that the recycling and processing of the plastic waste is not being done by the organised sector in the State of Madhya Pradesh. The plastic is being collected through the rag pickers, sold to the kabadies from where it is being sent for the recycling out of the State or out of State. There are not much recycling / waste processing units in the State. However, in some of the Local Bodies, the plastic is being segregated from the Municipal Solid Waste as collected through the ragpicker which is being sent to the Cement Plants for the co-processing. Some NGOs are also engaged in this social work for the improvement of the livelihood of the ragpickers. It is clear from the above that the Local Bodies are not getting any annual reports from the recyclers or the plastic waste processors. The annual reports are being prepared by the Local Bodies on the basis of the Municipal Solid Waste collection and partial segregation. It is the reason that most of the Local Bodies are not submitting the annual reports.

2. Quantification of the Plastic Waste generation:

The quantification of the plastic waste generation has been done on the basis of the annual reports received from some of the Local Bodies and some information has been gathered by interviewing the ragpickers. The exercise has been done through 16 Regional Offices of the Board. There were 377 local bodies and 05 cantt Boards responsible for the Municipal Solid Waste Management in the State during 2016-17, the Region Wise detail is as follows:

The quantity of the Municipal Solid Waste disposal facilities is considered as 6996 MT/day. The quantity of plastic waste generated as per the information received from the 377 local bodies during the year 2016-17 is **50457.07 MT** which is around 2% of the quantity of the Municipal Solid Waste considered as a designed quantity for the purpose of proposed disposal facilities. Since, most of the local bodies are very small and listed as Nagar Parishad; hence, the quantity seems to be realistic. The information is not received from the Cantt Boards.

3. Plastic Carrybag manufacturing, recycling and Multilayer Packaging Industries:

The quantity of the plastic goods manufactured in the State is negligible in comparison to the shipping from the neighboring States. It is estimated that around 60000 MT/Year plastic goods (Toys, Molded Furniture, Domestic Goods, Packaging Materials and Polythene Carry Bags etc.) are coming from Delhi, Maharashtra, Gujarat, Punjab, Haryana, and Chhattishgarh & Uttar Pradesh. Delhi, Bombay, Nagpur, Baroda, Chandigarh, Raipur and Kanpur are the major feeder of Polythene Carry Bags to the State. The regular inspections of the carry bags manufacturing units are being carried out by the Regional Offices of the Board and no violation has been observed during the year. The Region wise list of the plastic carrybags manufacturing, plastic recycling through

It is also to be noted that no unregistered plastic carry bag manufacturing or recycling unit established in the residential of unapproved areas have been identified during the year.

4. Municipal Solid Waste management and Plastic Waste Segregation:

The planning has ben done by the Government of Madhya Pradesh for the clusture approach for the Municipal Solid Waste management and Plastic Waste Segregation in the State to start Waste to Energy (WtE) projects. The whole State has been devided in 26 clusters which cover all the 377 local bodies. The name of the proposed cluster, no of local bodies covered under each cluster, the designed quantity of Municipal Solid Waste, type of Municipal Solid Waste processing and current status is as follows:

The plastic waste is generated after the use of plastic goods. The segregation of the plastic waste from the Municipal Solid Waste has been considered as integral part of the above projects. The operator of the facility will be responsible for submission of the annual reports accordingly. However, the non-recyclable plastic waste is being segregated partially through the ragpickers, the lowest link of the society, are engaged in the plastic waste segregation from the MSW. Most of the rag pickers pick recyclable plastic waste from the MSW to earn around 45 to 60 rupees per day by selling it @ Rs 8-10 per kg. The non-recyclable part of the plastic waste is not of interest for the rag pickers due to its low price. The State Pollution Control Board insisted the Rotary Cement Kilns for the co -

processing of the non recyclable Plastic Waste (which counts approximately 25% of the total plastic waste) in the State. Being less profitable, most of the rag pickers are not interested for collection of non recyclable Plastic Waste due to the decentralized method of plastic waste collection, and unorganized system of waste trade. It is important to address these work links, in order to tackle this problem. NGOs are close to the system of plastic waste collection. Hence, the role of the NGOs is important for convincing the rag pickers for the collection of the non-recyclable plastic waste. NGOS can create sufficient confidence among the kabadies and rag pickers for performing the task. They can also work as a bridge between the Local bodies and the waste collectors (rag pickers) and kabadies. An NGO working in Bhopal since year 1998, for the welfare and skill development of the rag pickers has been able to convince the rag pickers for collection of non recyclable plastic waste for Bhopal city. As a result about 125 rag pickers and 8 kabadis were engaged in this task. The NGO has facilitated collection through 5 centers, the rag picker are getting earning from the collected waste. This system accelerated the process of collection of non-recyclable plastic waste for its final disposal.

4. Plastic waste Disposal:

The Madhya Pradesh Pollution Control Board implemented an Innovative Scheme for final disposal of Plastic Waste in the State. The work is being executed in coordination with the State Government, certain NGOs, Municipal Corporations, local Kabadis and Cement industries of the State. A strategy was formulated for the disposal of plastic waste by identification of different stakeholders and their linkages in the process.

The Cement Industries of State came forward to join hand in the innovative scheme initiated by the State Pollution Control Board. The Cement Industries made proper arrangement for the proper feeding of plastic waste in the kiln and obtained permission under regulatory provision; from the Board. The Cement Industries are regularly monitoring emission and the clinker quality after co-processing of plastic waste. The co-processing of plastic waste in the Cement Kilns is in progress and no ill effects of this method of final disposal are reported till now.

The coprocessing of the plastic waste in the cement kilns started in 2008-09 and about 38563.86 MT of plastic waste has been utilised till 2016-17 for this purpose. The cement industries are procuring plastic waste through NGO or directly from the waste collector


i.e. kabadies. Some of the local bodies are also providing the plastic waste to the cement industries. The detail of the plastic waste coprocessed by the cement industries is as follows:

The Municipal Local Bodies sent around 4383.115MT plastic waste to the cement industries, 2000 MT for the recycling units and 54 MT for utilisation in the Road construction during 2016-17. The cement industries procured around 12642.89 MT plastic wastes through the NGOs or directly from the waste generators for the coprocessing during this year. Hence, around 16994.15 MT plastic wastes have been coprocessed by the cement industries during the year.

5. Constitution of the State Level Advisory Committee:

The State government, for the purpose of effective monitoring of implementation of the rules, 2016 has constituted a State Level Advisory Committee under Rule, 16 by the Urban Development and Environment Department, vide letter No F-5-4/2011/32 dated 8/12/2016 and attached at **Annexure-1**. The joint Director, Urban Administration & development department is the coordinator of the committee. However, no meeting of the committee has been convened during the year.

6. Publication of a Public Notice:

The Hon'ble Chief Minister of Madhya Pradesh announced on the occasion of 26th Jan, 2016 to implement complete ban on the manufacture and use of Plastic Carry bags in the State from 01st May, 2017. The matter was related to the buiseness freedom; hence, permission was required from the Central Government for implementation of the same. The State Government sent a proposal to the Home Department, Government of India for approval in the amendment in the "Jaiv Anashya Apshishth (Niyantaran), Adhiyam, 2004", an Act passed by the State Governemt for the control of non-biodegradable waste in the State on 12/04/2017. The same was approved by the Hon'ble President of India on 29/04/2017. The State Government notified amendment in Madhya Pradesh Jaiv Anashya Apshishth (Niyantaran) Adhiyam, 2004 through an ordinance "Madhya Pradesh Jaiv Anashya Apshishth (Niyantaran) Sanshodhan Adhyadesh, 2017 on 22nd May, 2017 and The Environment Department of the State issued notification no F-5-2-2015-18-5 Bhopal dated 24th May, 2017 as under:

"In excercise of the powers conferred by Section 3 of the Madhya Pradesh Jaiv Anashya Apshishth (Niyantaran) Adhiyam, 2004 (No 20 of 2004), the State Government, hereby, in the Public interest completely ban the production, storage, transportation, sale and use of plastic carry bags in the entire State of Madhya Pradesh from the date of publication of theis notification in the Mahya Pradesh Gazette."

The public notice as advised by the Central Pollution Control board was pending for the publication for the compliance of the annouancement made by Hon'ble Chief Minister. A comprehensive public notice has been published on 20/7/2017 in two daily news papaers having wide circulation in the State after issuance of the notification regarding the complete ban on the plastic carry bags in the State. The copy of the same is attached at **Annexure-2**.

प्लास्टिक थैलियों के उत्पादन, भंडारण, परिवहन, विक्रय एवं उपयोग पर प्रतिबंध

मध्यप्रदेश शासन, पर्यावरण विभाग, मंत्रालय, भोपाल की अधिसूचना क्रमांक एफ 5-2/2015/18-5 भोपाल, दिनांक 24 मई, 2017 के माध्यम से मध्यप्रदेश जैव अनाश्रय अपशिष्ट (नियंत्रण) अधिनियम 2004 की धारा 3 में प्रदत्त शक्तियों का उपयोग करते हुए लोकहित में सम्पूर्ण मध्यप्रदेश में प्लास्टिक थैलियों के उत्पादन, भंडारण, परिवहन, विक्रय एवं उपयोग पर दिनांक 24.05.2017 से पूर्ण प्रतिबंध लागू किया गया है। अधिनियम के प्रावधानों का उल्लंघन पाये जाने पर जैव अनाश्रय अपशिष्ट (नियंत्रण) अधिनियम, 2004 की धारा-9 के अन्तर्गत दण्ड का प्रावधान है। उल्लंघन पाये जाने पर एक महीने तक का कारावास अथवा एक हजार रुपये तक का जुर्माना अथवा दोनों से एक साथ तथा उल्लंघन की निरंतरता पाये जाने पर कारावास तीन महीने तक एवं जुर्माना पाँच हजार रुपये तक अथवा दोनों से एक साथ दण्डित किये जाने का प्रावधान है।

उपरोक्त प्रतिबंध के साथ-साथ भारत सरकार, पर्यावरण एवं वन मंत्रालय की अधिसूचना क्रमांक सा.का.नि. 320 (अ) दिनांक 18 मार्च, 2016 के माध्यम से केन्द्र सरकार द्वारा जारी अपशिष्ट प्लास्टिक नियम, 2016 के सभी अन्य प्रावधान प्रभावशील हैं। उपरोक्त नियमों में प्लास्टिक अपशिष्ट प्रबंधन हेतु स्थानीय नगरीय निकाय, ग्राम पंचायत, प्लास्टिक अपशिष्ट उत्पादनकर्ता, प्लास्टिक उत्पादक, आयातकर्ता व ब्राण्ड स्वामी के उत्तरदायित्व निहित किये गये हैं। पर्यावरण के हित में सर्वसंबंधिता को निम्नानुसार सूचित किया जाता है :-

1. पान मसाला, तम्बाखु और गुटखा की पैकिंग में प्लास्टिक सामग्री/ विनाईल ऐसीडेट मेलिक एसिड विनाईल क्लोराईड का उपयोग नहीं होगा।
2. प्लास्टिक शीट या मल्टी लेयर पैकिंग जिस पर निर्माता का विवरण या मार्क स्थापित नहीं है उसका क्रय-विक्रय नहीं होगा।
3. प्लास्टिक शीट/फिल्म का निर्माण नियम 2016 में किये गये प्रावधान के अनुसार लाइसेंस या रजिस्ट्रेशन के बिना नहीं किया जायेगा।
4. प्लास्टिक केरी बैग के स्थान पर केन्द्रीय प्रदूषण नियंत्रण बोर्ड द्वारा प्रमाणित व आई.एस. - 17088 मानकों के अनुरूप निर्मित कम्पोस्टेबिल (बायो वेस्ट) केरी बैग का उपयोग किया जा सकता है।
5. अनाधिकृत क्षेत्रों में अनाधिकृत रूप से संचालित प्लास्टिक फिल्म निर्माता इकाईयाँ को जिला प्रशासन के माध्यम से तत्काल बन्द किया जाये।
6. स्थानीय/नगरीय निकाय एवं ग्राम पंचायतें खुले क्षेत्र में प्लास्टिक अपशिष्ट को जलाने पर प्रभावशील रूप से नियंत्रण करेंगी।

अपशिष्ट प्लास्टिक नियम 2016 के प्रावधानों का उल्लंघन पाये जाने पर पर्यावरण (संरक्षण) अधिनियम, 1986 की धारा-15 के अन्तर्गत पाँच वर्ष तक कारावास या एक लाख रुपये तक का जुर्माना अथवा दोनों का प्रावधान है। नियमों का लगातार उल्लंघन पाये जाने पर पाँच हजार रुपये प्रतिदिन अतिरिक्त जुर्माने का प्रावधान है।
